ORGANIZATIONAL BRIEF

This is an initial Certification Audit and the Scope is Individual Certification of WSCSB - ENCHIAP ESTATE PHASE 3, PANTU [EEP3] under the standards MSPO-3:2013 General Principles for Oil Palm Plantation and Organized smallholders.

WSCSB - ENCHIAP ESTATE PHASE 3, PANTU [EEP3] main office is located at N0 449, Heights Drive Commercial Centre, Jalan Stutong 93350 Kuching Sarawak while the plantation site is located at NCR Kawasan Enchiap, Pantu (Phase 2), 95000 Sri Aman, Sarawak [Geo-coordinates **N1.208311, E111.220295**]; approximately 155 km from Kuching City; accessible by land; about 2 hours driving journey using the Pan Borneo Highway. The plantation is established in January 2019 and currently the total Certified Area is **366.45** hectares while total Planted Area is **312.70** hectares; with 2 planting blocks and 37,525 palm stand count. The land topography is generally flat and undulating with soil type shallow peat & sandy loam.

The main activities of EEP3 are to produce, transport and sale of sustainable fresh fruit bunches [FFB]. At the site EEP3 currently employ 25 people (comprising 2 office staffs and 23 workers). Main resources and amenities are currently shared with sister estates [Enchiap Estates Phase 1 & Phase 2]

The assessment method used in this audit follows the principle of three (3) Ps (paper, practice and people).

This certification assessment is a sampling process where management systems effectiveness and efficiency are confirmed via Audit Trail that the Auditor established to make an accurate conclusion. Information and data were systematically gathered and documented from interviews (with a cross section random sample of stakeholders), observations of process and activities, field audit and review of documentations and records. Assessments were done at the Plantation Office and field sites.

In both Audit stage 1 & 2, interviews were conducted with stakeholders comprising staff, workers and surrounding local community to find out their understanding of MSPO principles, its' importance to sustainable growth and production of oil palm products.

Other notable findings during the audit are the following:

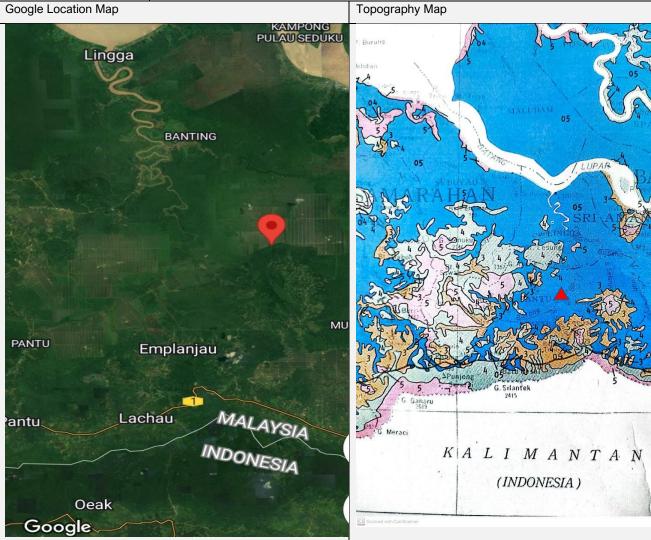
- a) There is a good working relationship between the management, staff and workers;
- b) Workers are provided with good and habitable housing [recently built] & living conditions with adequate facilities and amenities. The accommodation, water supply and electricity are provided free of charge.
- c) EEP3 management had installed a satellite communication 'booster' for communication needs of site employees.
- d) Use of solar energy is well established with solar panels installed at estate office & workers quarters

The following 6 findings have been identified in Stage 1 and actions taken as follows:
