#### ORGANIZATIONAL BRIEF

This is Surveillance Year 04 Certification Audit and the Scope is Individual Certification of LS SURIA GROUP, LUNDU SARAWAK under the standards MSPO-3:2013 General Principles for Oil Palm Plantation and Organized smallholders.

LS SURIA GROUP main office is located at Lot 41, 45 & 46, Block 1, Gading-Lundu 94500 Kuching Sarawak

LS Suria Plantation is located at Lot 41, 45 & 46, Block 1, Gading-Lundu 94500 Kuching [Geo-coordinates: N1.612022, E109.780164], approximately 15km from Lundu Town and 87km from Kuching City. The Plantation is established in 2005 and currently the total certified and planted area of 406.05 Hectares with 14 planting blocks and 62,567 palms. The land topography is undulating and mainly sandy soil. At the site LS Suria Plantation employed 17 people (comprising 11 workers and six staff). The estate village comprise the Estate office, stores and worker's quarters.

Aktif Muhibbah Estate is located at NCR Land, Kampung Opek, Biawak Lundu 94500 Kuching Sarawak (Geocoordinate N1.607204, E109.793230), approximately 12km from Lundu Town. The Plantation is established in 2005 and currently the total certified and planted area of 100.00 Hectares with 9 planting blocks and 13,600 palms. The land topography is lowland and mainly sandy soil. At the site Aktif Muhibbah Plantation employed 7 people (comprising 6 workers and 1 staff).

In both estates, the staff and workers are remunerated above Minimum Wage Order currently in force. The workers living conditions meet the minimum of living standard of Housing and Amenities Act (Act 446) as well as health and safety regulations. Both Estates are provided with amenities that include treated water, electricity, telecommunication service and domestic waste collection and disposal

The main activities of **LS SURIA GROUP** are to produce, transport and sale of sustainable fresh fruit bunches [FFB].

The assessment method used in this audit follows the principle of three (3) Ps (paper, practice and people).

This certification assessment is a sampling process where management systems effectiveness and efficiency are confirmed via Audit Trail that the Auditor established to make an accurate conclusion. Information and data were systematically gathered and documented from interviews (with a cross section random sample of stakeholders), observations of process and activities, field audit and review of documentations and records. Assessments were done at the Plantation Office and field sites.

During the Audit, interviews were conducted with stakeholders comprising staff and workers to find out their understanding of MSPO principles, its' importance to sustainable growth and production of oil palm products.

Other notable findings during the audit are the following:

- a. There is a good working relationship between the management, staff and workers;
- b. Workers are provided with habitable housing & living conditions with adequate facilities and amenities. The accommodation, water supply and electricity are provided free of charge.
- c. Public telecommunication coverage is available in the area.
- d. Electricity is supplied with SESCO grid at the office, stores and workers quarters. The estate also uses solar panel for electricity supply at the worker's quarters.
- e. Staff and workers are renumerated above minimum Wage Order 2022.
- f. Other benefits include medical and annual bonus,) and paid home leave for TKI. Medical treatment [for normal ailment] is provided free by LS SURIA GROUP. The Estate Supervisor and Mandor are also provided monthly handphone and petrol allowance and incentive allowances for FFB evacuation (for the drivers)
- g. There is no evidence that the estate is processing non-sustainable FFB

The Audit team has conducted a rigorous assessment **of LS SURIA GROUP** through Field Audit Checklist, Audit Report Checklist, documents review and Stakeholder's Consultation. It is evidenced that **LS SURIA GROUP** has complied and conformed to MSPO2530-3:2013 Certification Standards, conditions and requirements.


